The participants represented four of the five existing TBRs in Europe and a number of very interesting TBR initiatives.

Various colleagues from France, Macedonia, Serbia & Montenegro, Turkey, Slovakia and UNESCO ROSTE Venice unfortunately could not attend the informal meeting because of duties in the parallel running formal meetings. They had declared their great interest in the TBR issue and asked for receiving the minutes of the meeting.

First of all, the participants regretted that none of the eight formal/official workshops was dedicated to the TBR issue and ask the MAB Secretariat to plan for a workshop on TBR issues to be carried out in the course of the next EuroMAB Conference in Turkey in 2007.

Furthermore, the participants exchanged on recent developments in the creation and functioning of TBRs in Europe and worldwide.

Roland Stein reported on "Following-Up on SEVILLE + 5", the '2004 International Conference & Expert Workshop on Transboundary Biosphere Reserves', which was carried out in "Pfälzerwald – Vosges du Nord" TBR.

He presented the participants' "Message to the UNESCO MAB Programme" which had been sent to the Secretary of the MAB Programme, Mr N. Ishwaran, in June 2005 and which, on behalf of Mr Ishwaran, was replied to by Ms Jane Robertson, telling that "the Bureau (MAB ICC) noted that the recommendations from the Conference have indeed been duly taken into account in the draft UNESCO Programme and Budget for 2006-2007 for MAB, which will in turn be examined and adopted at the 33rd session of UNESCO General Conference ...".

The "Message ..." gives recommendations to the MAB Programme on how to assist the TBRs and TBR initiatives in the establishment of networking and capacity-building, as well as on how to offer technical assistance/expertise advice and how to facilitate the process of implementing the officially recognized TBR recommendations, which were elaborated in the course of the 'SEVILLE + 5 Expert-Meeting' in Pamplona/Spain in 2000.

Finally the participants expressed their great interest in getting officially informed on how their recommendations and self-commitments were taken into account and adopted at the recent 33rd UNESCO General Conference and what this means in detail in terms of increased technical and financial support for the 2006–2007 period.

CHAPTER V

QUALITY ECONOMIES

The aim of the group meeting was to get a feedback on the labeling issue and to individual biosphere reserves of the EUROMAB zone willing to join the pilot project starting in 2006.

The discussion showed considerable interest by biosphere reserves to have a common image and labeling scheme for commercial goods and services. The pilot project will show the opportunities to create common visibility of the biosphere reserves.

SHORT SITUATION REPORT:

<u>Austria:</u> Mr Turk didn't know the proposal yet. It is a good idea but needs political support.

<u>Croatia:</u> The BR was discussed during the last meeting of the National MAB Committee in 2004 but there was no common agreement for a BR. The new National MAB Committee has still to be constituted. Mr Gugič will ask the new Committee and the UNESCO focal point at the Ministry of Culture to put the BR proposal on the agenda of the next National MAB Committee meeting.

<u>Hungary:</u> The BR proposal was presented by WWF Hungary and discussed during the last National MAB Committee meeting. The MAB Committee has suggested filling in the form. The Danube-Drava National Park Authority and the Ministry of Environment are supporting the idea.

<u>Serbia & Montenegro:</u> The BR nomination is currently in process. Current problem: Unsettled border issues with Croatia.

Slovenia: No participant from Slovenia.

<u>UNESCO</u>: It was stated that a joint nomination would be more successful. UNESCO Roste representatives have offered to facilitate a side meeting with all National MAB Committees/UNESCO Commissions concerned within the next meeting of MAB/UNESCO of the SEE region. It was also said that the proposal would need political/ministry agreement between the countries involved.

CONCLUSIONS:

- The idea of a Transboundary BR was very much appreciated amongst the participants, next steps need to be taken to develop the proposal.
- As a next step, a common meeting between the relevant MAB Committees and UNESCO Commissions was discussed. UNESCO Roste has offered its help.

The overall aim is to involve students from Euromab countries in CoMa BRs management, by offering them the opportunity to integrate their external assessment and skills for building up environmental assessment and concrete proposals.

These sessions would concern groups of about 10 volunteer students for a two-weeks period of field work on a hosting BR. The themes would have to be studied through a multidisciplinary approach including social and biological sciences.

A first round of summer school could take place in insular BRS: Menorca, Hiiumaa, Archipelago Sea, Mer d'Iroise.....
